The calendar must not be used to simply advertise or publicise the main activity of the business. Examples below are given to assist. The interpretation of 'in the spirit of a community calendar' will be made solely by the InTarra administrators.

The following are examples only:

- A golf club cannot add 'golf this week' but can add special golf workshops of a non-regular nature or notice of visiting celebrity golfer;
- A cafe cannot add its 'weekly specials' but can add 'live music events';
- A country club cannot add 'special pokies night' because that is a main business activity.
- A new business or business that has been closed for an extended period can place an 'Opening Week' entry in the calendar.

There are exceptions to these terms for community groups, not for profits, newsletters and community-related media.

STOP - PLEASE READ THIS...

- A club, business or group cannot have an InTarra account. Instead, it must nominate an actual person or actual people to be their representative(s)
- Your representatives must use their own **personal** InTarra account to enter items for your Organisation. (Note: Their personal details will not be shared with your organisation.)
